CLASS H SWINE RULES

Illinois Swine

Accompanied by health certificate issued within 90 days prior to exhibition. Swine shall be individually identified by metal ear tag, tattoo or recognized breed ear notch. Ear notch identification is acceptable only for animals accompanied by breed registration certificate. Health certificate shall show:

- 1. All gilts exhibited in the division must have been farrowed on or after January 1, current year, barrows January 15, current year
- 2. All swine must be owned by exhibitor by June 1, current year.
- 3.All purebred gilts entered must be registered in the name of the exhibitor only. All animals exhibited shall be plainly ear marked and these ear marks will be inspected.
- 4. Each exhibitor must be responsible for his market animal (barrow to be weighed at the designated time.)
- 5. Barrow Class weights may be altered by superintendent to balance classes. .
- 6. No gilts will be shown in the market barrow class.
- 7. The show is open only to Effingham County.
- 9.ONLY two (2) barrows may show in each division, not including carcass barrow.
- 10. Animals must be in place by 8 a.m., Saturday and will be released after the show Tuesday morning.
- 11. Weigh barrows and cross bred gilts Saturday, weigh in TBA.
- 12. An individual may show a total of two (2) gilts in each class (purebred, maternal, and market).
- 13. Crossbred gilts must be weighed
- 14. NO back up animals are allowed
- 15. No washing of swine during any OTHER 4-H Livestock show.
